### IGF 2017: shape your digital future!

The 2017 edition of the Internet Governance Forum was a call to action for us to work on the construction of the digital future. As members of this great global community or simply as users, Internet is present in our lives and the future depends on the actions of everyone.

Here we share brief summaries of some of the debates and events of this meeting.



### Do not take for granted the future of the Internet

Our President and CEO Kathryn Brown was very clear on the need to act quickly to shape the digital future that we hope for: "There is a commitment to an open, globally connected and secure network, but we can't take that for granted. If we don't address the concerns today, the future may be very different from what we imagine". Kathy urged the whole community to think with some urgency what we have to do and raise our voices to be heard. "If Internet is our life, then Internet Governance has to be the way we live regionally and globally", she reflected.





### **Encryption to ensurance security**

In his participation in the session on Internet interruptions, encryption and data flow, Raúl Echeberría highlighted the use of encryption as a key tool to guarantee the protection of personal data, business information and government interests. "Our life at this time is a digital life, so we need tools that protect our privacy and our interests guaranteeing freedom", he said. And he raised the debate of how to provide security tools to law enforcement agencies and order without affecting trust in the Internet, considering collaboration as the best way to achieve it.



### Community networks to connect the disconnected

"The digital divide is widening, today life is online, so the cost for people not connected is bigger than ever", said Sebastián Bellagamba at the IGF 2017. In this ecosystem, community networks are presented as a way to bring connectivity to remote areas and that more people can use of the Internet of opportunities. That is why the Internet Society urges the community to provide support to the people and organizations that are deploying these networks around the world, allowing them to work in a good spectrum, favoring a legal environment for their deployment or helping to create the capacities for people can manage their own networks. "If we help people who are developing community networks, we are already doing something to close the digital divide", said Bellagamba.

### Internet gives us hope

What would you do if the Internet no longer existed?, asked Raquel Gatto in her closing speech for the IGF 2017. Internet blockades and interruptions show us that this is a possible future if we take the wrong way today. We should not take the principles of Internet Governance for granted, and just as there are many forces for good, there are also forces for evil, which are reflected in the hopes and fears of users.

Quoting Vint Cerf, who affirms that the Internet is like a mirror of the society, Raquel urged to work together to change the aspects of the Internet that we do not like and to maintain the fundamental values that define an open, free, inclusive and safe Internet. Undoubtedly, the multistakeholder model and debate spaces such as the IGF are the best way to achieve this.

They have developed the LibreMesh firmware, which allows the autoconfiguration of devices for the deployment of mesh networks and a series of tools that facilitate the creation, monitoring and maintenance of networks.
